

The Fund aims to provide regular income and stable growth by investing exclusively in Government Securities issued by the Republic of Armenia or securities issued or fully guaranteed by the Central Bank of Armenia. It also gives the opportunity to earn higher after-tax returns as the income from the Fund is not taxed.

The Fund is suitable for conservative (risk averse) investors who seek to achieve high returns and take advantage of the fund's liquidity while not taking much risk. Class A is for long-term investing (more than 4 years), Class B is for medium-term investing (1-3 years) and Class C is for shortterm investing (less than 1 year).
